## **IX. Eligibility**

- a. All badminton enthusiasts are welcome to participate.**
- b. Maximum 3 events per person.**
- c. Not limited to one entry per discipline. (Example, a player may enter into 55+ singles or doubles and be able to enter a 2nd or 3rd singles or doubles event if otherwise eligible - Senior players are allowed entry into the lower age group, but not the higher age group.**
- d. All former and current national team players (regardless of nationality) under age of 50 will not qualify for Senior division, and must sign up in the Open division only.**
- e. Former national/professional players over age of 50 are not restricted to (d), but 2 former national/professional players may not combine for any events in the Senior division.**
- f. The youngest age allow for combined doubles events is 1/2 of the event age subtracted by 10 years. (For example 100+ combined, the youngest age allowed will be  $100/2-10=40+$  years).**
- g. Should any category have less than 3 people/team entries, that category would be merged with another similar event or cancelled.**
- h. Validity of age is proven with the year of birth on an identity card or passport. Age of the player will be the age as of Dec 31, 2018, i.e. determined solely by the birth year alone. (Example: 2018 minus 1983 equals 35 years old, people born after 1983 are not eligible to sign up for the senior event. Someone born in September 1978 is actually 39+ but is eligible to compete in the 40+ category). Players are required to carry government photo identifications as proof of age and identity. Any player who cannot provide proper identification will be disqualified from the tournament.**

- i. All husband and wife event entries must be verified.**

**X. Registration Procedures**

- a. Deadline for receipt of entry (Package D): July 6, 2018; this is subject to change depending on the number of entries received.**
- b. Deadline for receipt of full payment for the registration packages A, B, and C is now also July 6, 2018. THERE ARE ONLY A LIMITED NUMBER OF ROOMS AVAILABLE. ROOMS WILL BE ALLOCATED ON A FIRST-COME FIRST-SERVED BASIS.**
- c. Hotel and Event location: South Point Hotel, Casino & Spa, 9777 Las Vegas Boulevard South, Las Vegas, Nevada 89183.**

**XIII. Key Dates**

- a. A final list of players will be posted on the tournament website or [tournamentsoftware.com](http://tournamentsoftware.com) 10 days after the registration deadline. If there are any discrepancies, please contact the Tournament Committee within 5 days.**

- b. Official draw will be published on the tournament website or tournamentsoftware.com approximately 4 days before the tournament time**

#### **XIV. Conditions of Play (Game Rules)**

- a. Each match uses a 31 points system, players change sides when one team reaches 16 Pt first. First team to reach 31 points will win the match (sudden death at 30 points, no deuce). **Open events use the 3x21 rally points system.****
- b. Players have five minutes to show up on court once the match is called, if player is absent after five minutes, he/she will forfeit the match and their opponent will automatically win.**
- c. The period for warmup on the court before any match shall not exceed two minutes.**
- d. The Tournament Committee has the right to adjust the game schedule and court assignments. The player shall not object.**
- e. In case of protest/objections:**
  - i. Objection due to player's age: The objection must be made on the spot with the umpire of the match. Age will be verified via photo identification or official passport. If the player does not have valid documents, or the documents show ineligibility, then the player will be disqualified from the tournament.**
  - ii. Objection to disqualify a player: the objection must be made on the spot with the umpire of the match. The objector must provide sufficient evidence to show why the player should be disqualified.**

#### **XV. Prizes and Awards**



- a. Winners of both Open and Senior draws will be awarded medals. The Grand Prize money is \$8,000+ for Open events.**
- b. For Open events, each event with 8 or more entries, prizes will be awarded to top four. Events with 6-7 entries, prizes will be awarded to top three. Events with 4-5 entries, prizes will be awarded to finalists only.**
- c. All players will be given a commemorative T-shirt and qualify to enter tournament raffle.**

**By submitting the online entry for the 2018 Las Vegas World Chinese Invitational Badminton Tournament Open and Senior Divisions, the participant (and parent(s)/guardian(s) if participant is of minority age) affirms having read this document and agrees to be bound by its terms.**

**In consideration of my involvement at the 2018 Las Vegas World Chinese Invitational Badminton Tournament Open and Senior Divisions under the auspices of USA Badminton and WCBF-USA, I acknowledge, appreciate, and agree that**

**1. I risk bodily injury, including paralysis, dismemberment, disability, and death, and while particular rules of the sport, equipment, and discipline may reduce this risk, this risk of injury does exist, as well as the risk of damage to or loss of property. I knowingly and freely**

**assume all such risk; both known and unknown, even if arising from the negligence of the releases of others;**

**2. I willingly agree to comply with the state and customary terms and conditions for participation. If; however, I observe any unusual or unnecessary hazard during my presence or participation or if I observe any concern in my readiness for participation, I will immediately bring such to the attention of the nearest official and refrain from participation; and**

**3. I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, hold harmless and promise not to sue USA Badminton, the WCBF-USA organizing committee, their sponsors, their officers, volunteers, staff, sponsors and/or agents, (“releasees”) with respect to any and all injury and loss arising from my participation, whether caused by the negligence of the releasees, the condition of the premises or otherwise, except that which is the result of gross negligence or wanton misconduct, to the fullest extent permitted by law.**
